


ADJOURNMENT: There being no further business, Jeff Blenkush made a motion to adjourn. Gene Skaj seconded the motion. Motion carried.

WHEREAS, Minnesota Statute 205.185, Subd. 3, requires that the City canvass the results of the election between the third and tenth day after an election; and


WHEREAS, The Council met on November 14, 2016, as a canvassing board to review the results of the election.
